Our friend William Williams in the course of his religious visit acceptably attended this meeting and produced a copy of minute of Concurrence from White Water Monthly Meeting dated the 25th of the 9th month 1819, — Also our friend John Townsend Companion to our aforesaid friend acceptably attended this meeting & produced a copy of minute from the same monthly meeting & date

William Hobbs, William Harned, Henry Wilson, & Edward Bray report they attended the yearly Meeting, & produced to this meeting the Extracts of our last yearly meeting, & the reports of the Committee on Indian Concerns, the necessary parts of said extracts are (viz) a report was received from the Committee on Indian Concerns which was satisfactory, they are encouraged to pursue this interesting concern & Quarterly Meetings are directed to promote subscriptions to enable the Committee to Carry on the melioration of the condition of those people, —

The Discipline as revised by the meeting for sufferings in Conjunction with the Committee appointed by the yearly meeting last year, was taken up, & after examination was approved & adopted

The printing & distribution of which are referred to the care of the meeting for Sufferings—

This Meetings quota of yearly meeting stock is four Dollars which is proportioned equal between the two monthly meetings, —

William Hobbs reports the money directed to Jonathan Taylor as agent of the Indian Concern was accordingly paid, —

Handed from Lick Creek monthly meeting a request of friends at the Wabash, to have their meeting Established on first & fourth days of the week & for a preparative & monthly meeting, which after deliberate Consideration this meeting not fully uniting with it is refered back for farther Consideration, —

Handed from Blue River Monthly Meeting a request of friends at the Barrens to have their Meeting Established on fourth & first days of the week (except on week day week of Monthly Meeting) and to be known by the name of Mount Pleasant; The Committee appointed reported their unity therewith, with which this meeting unites & accordingly establishes the same, —

This meeting taking into Consideration a division of the yearly meeting and after deliberating thereon appoints, Jonathan Lindley, Matthew Coffin, Joseph Moore, Robert Hollowell, Owen Lindley & William Hobbs, to attend at Waynesville Ohio in 5th month next, the 5th day before their Quarterly Meeting to Confer with them & such other committees as may be appointed from other Quarterly Meetings in respect to petitioning the yearly meeting for said division, and the time & place of holding the Same, — The Clerk is directed to furnish each quarter expected to join in this Petition with a copy of this minute, —

Our Esteemed friend Hannah Thomson in the course of her religious visit acceptably attended this meeting & produced a certificate of Concurrence from Spring Monthly Meeting in Orange County North Caroline dated the 24th of the 4th Month 1819, with an endorsement thereon from the Western Quarterly Meeting held at Back Creek in Randolph County, North Carolina dated the 8th of the 5th month 1819 —
