The Representatives report they attended the yearly Meeting & produced the extracts thereof the necessary parts of which are follows (viz) The report from Miami Quarterly Meeting contains a proposition that a division of the Yearly Meeting take place in the following Manner (viz) Miami, West Branch, Fairfield, White Water & Blue River Quarterly Meetings constitute a yearly Meeting to be held at White Water on the Second day after the first 1st day in the 10th month The Meeting of Ministers & Elders on the Seventh day preceding — On Solidly deliberating on the Subject it appears to be the united Judgment of this & the Womens Meeting that the division take place in the manner proposed, The New Yearly Meeting to be opened in the 10th month of Next Year to be known by the name of Indiana Yearly Meeting for the State of Indiana, Illinois, & the Western part of Ohio —

The Committee on the Treasurers account report that they find a Balance of two Hundred & sixty one Dollars & Eleven Cents in his hand, one hundred & twenty two Dollars of which is uncurrent paper; the Quarterly Meetings quotas being nearly all paid in; on which the Indian Committee has a claim of \$200—

We propose that the Balance on hand after the Indian Committee be paid, be equally divided between the three easterly and five westerly Quarters —

We also propose the sum of Four hundred Dollars to be raised the ensuing year, Two hundred by the three Eastern and two hundred by the five Western Quarters, the latter sum to be paid to their anticipated Yearly Meeting

The proportion of this Meeting is thirty five Dollars which is directed to be raised Equally by Lick Creek & Blue River Mo Meetings & pay to this Meeting preceding the Yearly Meeting
