Lick Creek Monthly Meeting informs that Robert Holliday appeals from the Judg^t of that Meeting to this for his right of membership, Zachariah Nixon, Elisha Hobbs, Mark Bogue, William Hobbs, Solomon Ruddick, Mahlon Stephenson, William Cox & Solomon Cox are appointed to hear & investigate the case & report their judgment thereon to next Quarterly Meeting —

The representatives to the yearly Meeting report they all attended Except one friend & produced extracts from the minutes of that Meeting and the subject respecting raising Money for Building the Yearly Meeting House claiming the attention of this Meeting, the Sum of three Thousand Dollars was directed to be raised including that ahead raised, the proportion for this Meeting being Eleven cents in the Dollar, this Meeting directs the representatives to proportion our part amongst the monthly Meetings & inform them accordingly —

Monthly Meeting, which claiming the Solid attention of this meeting is united with & he left at liberty to proceed therein as truth may open the way & the Clerk is directed to endorse the same on his certificate
