The Committee appointed in the Case of Robert Hollidays appeal report, We the Committee appointed to here and determine the appeal of Robert Holliday, being met & after hearing the allegations on both sides are of the opinion that it will be best to reinstate him in consequence of the monthly Meeting too hastily disowning him without extending the necessary labor or giving him a fair hearing in this case which we submit to the Quarterly Meeting Zachariah Nixon, William Cox, Solomon Ruddick, Solomon Cox, Mahlon Stephenson, Mark Bogue, Elisha Hobbs, William Hobbs — with which this Meeting unites & confirms, the Clerk is directed to furnish Lick Creek Monthly Meeting with a Copy of this minute —

The appellant in the above case not being informed of the result, this meeting appoints John S. Chawner, Mathew Coffin & Zachariah Nixon to inform him thereof & report to next Quarterly Meeting —
