The 1.st 2.nd & 9.th queries were read and the answers thereto from the monthly meetings.—

That part of the yearly meeting minutes respecting appellants coming before this meeting it is directed that that paragraph be recorded on our minutes & on the minutes of each monthly meeting & also in some of our books of discipline and monthly meetings are directed to take the necessary care therein,— the Clerk is directed to furnish each monthly meeting with the necessary part of this minute.— The Yearly meeting's directions are as follows, (towit) "When Quarterly meetings committees report their judgment and the meeting is satisfied therewith, then a judicious committee should be appointed to take a solid opportunity with the appellant, and inform him of the meetings decision in the case, (the committee should give him the information, as soon after the quarter, as is practicable.) and report to the next meeting, and if the appellant be dissatisfied with the meeting's decision, he may notify the first or second Quarterly meeting after he receives such information of his further intention of appealing to the yearly meeting and not afterward."
