Answer $1\frac{\text{st}}{\pi}$ Meetings for worship and discipline, are attended by a considerable number of friends: in most of the meetings, there appears to be a neglect in the attendance of midweek meetings, on which account, care has been extended; unbecoming behavior guarded against, and mostly avoided. The hour of meeting, nearly observed. — Ansr. $2\frac{\text{nd}}{\pi}$ Love is maintained in a good degree, by most friends: though not so general, as is desired, wherein, care has been extended. Talebearing, and detraction, generally discouraged. When differences arise, endeavors are used to end them.

Answer 3rd Many friends endeavour, by precept, and example, to educate their children, and those under their care, in plainness of speech, deportment, and apparel; and to guard them against reading pernicious books, and from the corrupt conversation of the world; encouraging them, frequently, to read the holy scriptures; yet, deficiences exist in some, in most parts of that query, particularly, dress, and address; wherein, care has been extended.

Answer 4th friends appear clear of importing, vending, distilling, and the unnecessary use of spirituous liquors, (except in three instances of the unnecessary use, which are under notice,) and of frequenting taverns, or places of diversion; moderation, and temperance, observed in a good degree, by most friends.

Answer $5\frac{th}{\pi}$ the necessities of the poor, attended to, and care taken, to promote the school education of their children.

Answer $6\frac{\text{th}}{\text{c}}$ Friends maintain a faithful testimony against a hireling ministry, oaths, military services, clandestine trade, prize goods, and lotteries: except one instance of taking an oath before a justice of the peace, and three instances of traning with militia, all of which, are under notice.

Answer $7^{\frac{th}{\pi}}$ Friends appear careful to live within the bounds of their circumstances, and to avoid involving themselves in business, beyond their abilities to manag; and appear to be just, in their dealings, and punctual, in complying with their engagements.

Answer $8\frac{\text{th}}{\text{c}}$ Friends bear a testimony against slavery, and provide, in a suitable manner, for those people of colour, under their direction, as far as appears.

Answer 2^{nd}_{π} Friends appear careful to encourage the education of their children, under the tuition of teachers, in membership with us.
