

Blueriver Quarterly meeting of friends held at Highlands Creek Washington Cou Ind 27<sup>th</sup> of 2<sup>nd</sup> mo 1869

in the absence of the assistant clerk Elias H Trueblood is appointed for the day

By written reports from the mo meet constituting this the following named fds wer appointed representatives viz from B River Abram Bundy Nathan Trueblood Tho<sup>s</sup> Morris & Paschal Way from H Creek Parker & Moses Reynolds from C Creek W<sup>m</sup> Hoyt & Tho<sup>s</sup> Flower from Bville Jehu Allen & W<sup>m</sup> L Dorland who being called wer present from B River & one from H Creek — reasons were recieved for the absent representatives

The 1<sup>st</sup> 2<sup>nd</sup> & 9<sup>th</sup> queries wer read and answers thereto from our subordinate meetings of which the following is adopted as a summary viz

an<sup>s</sup> 1<sup>st</sup> Our meeting for worship & discipline have all been attended, mid-week meet'gs are mostly small – unbecoming behavior therein mostly avoided – the hour pretty well observed

an<sup>s</sup> 2<sup>nd</sup> One mo meeting reports christian love not sufficiently maintained & that talebearing & detraction are not enough discouragd, endeavors used to end differences

an<sup>s</sup> 9<sup>th</sup> Endeavors are used to deal with offenders as queried, yet we believe more timely care in this respect would be proffitable

By the reports from Clear Creek & Benjaminville mo meetings it appears they are united in requesting the establishment of a Quarterly Meeting to be composed of C Creek & B,ville mo meetings to be known as Clear Creek Quar Meeting of friends & to be held alternately at Clear Creek & B'ville on the 3<sup>rd</sup> 7<sup>th</sup> day in 2<sup>nd</sup> 6<sup>th</sup> 9<sup>th</sup> & 12<sup>th</sup> mo at Clear Creek in 2<sup>nd</sup> & 9<sup>th</sup> months & at B. ville in the 6<sup>th</sup> & 12<sup>th</sup> mo's, to convene at 11 oclock the meeting of ministers & Elders to be held the day preceeding at 11 oclock — This meeting after a time of deliberation thereon unite in appointing Paschal Way Moses Reynolds W<sup>m</sup> Lewelling Tho<sup>s</sup> H. Trueblood, Abram Bundy & Elwood Trueblood a committee to unite with a like committee of women friends in visiting them on the subject as way appears to open & report to this Meeting in 9<sup>th</sup> mo next

By minutes of last meet it appears the Clk was directed to inform Bville Mo' Meet that a reason would be expected at this for the nonattendance of J B Benjamin one of its appointed representatives to last mee't but no report appearing the Clerk is directed to inform that meet that a reason will be expected at our next

Clear Creek Mo Meet forwarded in its report reasons for the nonattendance of John W Price & Mark Penrose of this meet in 9<sup>th</sup> mo last — By directions of last Qr' to the representatives to apportion the amount of \$10, to be raised by this Meet for yearly meeting stock, between the mo meetings, & report to this — they report B,R 33 percent C,C 34 H,C, 13 BV, 20 which is in round numbers for B,R \$19,80 for CCreek \$20,40 for B,ville \$12,00 for Honey Creek \$7,80 The Clk is directed to inform the mo meetings of the amt to be raised severally & request them to open free subscriptions for the same & report to this Meet in 8<sup>th</sup> mo next

Clar Creek informs that the circular indulged mee't held monthly in white side cou is orderly continued under the care of a com

Moses Reynolds Tho<sup>s</sup> Morris, W<sup>m</sup> Lewelling & Henry Atherton are appointed to confer together on the subject & report to next mee't the name of friend to serve this meeting a clk & one for assistant
