	To Blue River Quarterly Meeting to be held in Chicago second month 25 1933
	In response to the desire of Eleventh Month quarter for official information regarding the setting up of our "Relief Funds" and who constitutes the present board of trustees in charge of these funds, your committee make report.
Origin of Alvin Fawcett Fund Uses of the fund	Eleventh Month 25–1876. Indiana Yearly Meeting apportioned what it considered the rightful share of Blue River Quarterly Meeting (formerly a part of Indiana Yearly Meeting) from accrued interest from an endowment fund left to said yearly meeting.
	On date above given four trustees were appointed "to have charge of the Albon Faucet Fund and are directed to place the principal at interest for charitable purposes and report to this meeting from time to time as may appear best" (quotation extracted from minutes of 11 th mo. 25 1876. signed by W. L. Dorland Clerk.)
	Likewise we find in minutes of Second Month 24 – 1906 an informative statement by the chairman-Treasurer of what is called the Alvin Faucett Fund the "trustees are to hold this fund in trust to draw interest, and such interest to be used at the committees discretion for charitable

purposes"

signed by Abel Mills, Chairman-Treasurer. "Charitable purposes" has always been construed by the trustees to mean <u>aid</u> or <u>assistance</u> to the <u>poor</u> or <u>needy</u> of our membership

It is the opinion of your committee that it should so remain.

Fifth month $22\frac{\text{nd}}{\text{m}}$ 1909 "Clarkson Wood on behalf of the members of Richland Meeting (Hoopeston Illinois) informs this meeting that they have donated \$572²⁴ to Blue River Quarterly Meeting (from sale of meeting house property) Donation gratefully acknowledged and committee appointed to concider disposition of donation and report at next meeting"

In ninth month this committee reported.

"Your committee xxx recommend that Blue River Quarterly Meeting x place in trust the monies donated by Hoopeston Friends xxx that the interest therefrom be used for philanthropic purposes, and since the meeting already has custodians of the Alvin Faucett fund we recommend x that the trustees of the Alvin Faucett fund be made the trustees of the Hoopeston Fund"

(signed for committee Albert T. Mills)

It was recommended by above committee that the Chicago Meeting should have a representative on the "Board of Trustees" Accordingly the number of trustees was increased to five members. Thomas A Jenkins being duly appointed on 11^{th} mo 27 - 1909.
