In view of the fact that the American Friends Service Committee have an active Peace Section now in operation it is suggested that  $$35^{\underline{00}}$  be forwarded to this committee when available for use.

We are informed by representatives that Chicago Meeting expects to take up the study of Military Training in their group in the near future. The Student Hostelry or Student House idea for the University of Chicago has been discussed and considered in conjunction with the General Advancement Committee. It is hoped that a plan may be worked out and developed. The Quarterly Meeting had under discussion the American Legion and its attitude towards Peace. Its policy seems now to be directed rather largely by militarists while its early declarations were strongly against the exhibition of force in settlement of international disputes.

Our Peace relations with Canada were also discussed. Lucretia Franklin brought out the need of emphasis on the fact that the United States has no aggressive motives toward the annexation of Canada. Her residence in the Dominion had emphasized the need of care as she had found to her surprise on going there that a strong suspicion exists that the United States has selfish Imperialistic motives toward her neighbor. Friends should use every opportunity to aid in putting down such suspicion or cause for it on the part of our government.

The treasurer is directed to notify the Subordinate meetings of the quota to be raised for the Yearly Meeting Funds.

Having completed business coming before us we conclude to meet at the Hull House in Chicago in Second Month next.
